Another addition to the list of famous seconds

Who came second in the 1992 Olympic Games in Barcelona to Linford Christie? We should know this as South Africans because we had a famous neighbour in that race and there was a lot of excitement at the possibility of an African winning the 100m. He also claimed silver in the 200m race. By now many of you have correctly guessed who I am talking about. He went on to get silver for both the 100m and 200m in the 1996 Atlanta Olympics and took gold in Johannesburg at the 1998 World Cup (IAAF Intercontinental Championship). To put the rest of you out of your misery, I am referring to Frankie Fredericks the only Namibian to win an Olympics medal.

There have been many other famous and not-so-famous seconds, like Buzz Aldrin (2nd man on the moon), John Adams (2nd US president), Velenkosini Hlabisa (2nd IFP leader) and so on. Some people make a habit of coming second – think of the South African golfer Lodewicus Theodorus Oosthuizen (more famously known as Louis Oosthiuzen) who has come second in the last two golf majors this year; The US Open and The PGA Championship, to add to three other three other second place finishes in the past 9 years. One could add any of Michael Schumacher or Lewis Hamilton's team mates to this list.

After that introduction I am sure that many of you can figure how Gradidge-Mahura Investments fared at this year's Top Private Banks and Wealth Managers Survey. Yes, we came second. But it was the number of seconds that made many in the industry up and take note. We qualified for seven categories in this year's survey. We finished top three in all categories – the only boutique firm to do so – and we won one category. These results are summarized in the table below:

We are proud of the results that we achieved this year. While we ranked 2nd in five categories, we were the only boutique firm to rank in the top 3 places in every category that boutique firms qualified to enter. The rankings are based on several criteria; client feedback, a technical assessment of a case study, and judge's input based on firm information provided. The People's Choice award is based solely on client feedback. We suspect that our technical submission was very strong as it is the first time since 2018 that this has been included in the survey. In 2018 GMI won the overall award, two categories and People's Choice.

Top Financial Adviser: Virath Juggai

Like Louis, we managed one big victory when Virath walked away with the top financial adviser / relationship manager award. The top financial adviser / relationship manager award was introduced in 2019. GMI advisers did not qualify in those years as the firm did not get sufficient client responses. In 2021 we met the minimum criteria to qualify



and, unsurprising to the GMI team, Virath Juggai won this coveted award. Virath joined GMI in March 2011 and has been a key member of the team. In 2012 Virath won the Top Student award for the Competency exam for the Post Graduate Diploma in Financial Planning. This is an exam which has had a below 20% pass rate in the past few
